## PUG at the Nationals in Washington DC

Phase Up Group is a peer run support group that is comprised of alumni and current participants of the treatment courts. Phase Up Group was a dream of the courts. After court sessions, support group meetings were had but there was still something missing. In 2014, PUG started meeting more often and opened up opportunities for members to plan and make decisions with regard to pro-social events. There was a disconnect that we identified. Our pathway into recovery was a result of breaking the law and choosing a court program to make a change for the better. While going through the process, it can be overwhelming and many isolate. Not surprising as you are mandated to change everything that you know (people, places, and things). PUG asked the courts if they could host a bowling event then a sports trip, they said yes and this opened the door to new friendships. And the rest is as they say "history".

PUG to date has hosted outings to sporting events, 1st and 2nd annual picnics with the 3rd coming soon (with a tradition of rain), movies and popcorn, the theatre, planning meetings on Tuesdays and after court (OWI, Sobriety, Women's Drug Court and Men's Drug Court-NORP) support meetings.

Because of the support and respect that the courts have in Phase Up Group, we were nominated for and received the Hero Award from the Michigan Association of Treatment Court Professionals (MATCP). PUG was the first "Group" in the conference's history to have received this award.

With such an honor under our belt, PUG was motivated to do more and take our ideas of support to the next level. A certain judge put it out there that our vision and success needs to be shared.

We filled out the application. A couple of months later, we received an invitation to speak at a breakout session at the National Association of Drug Court Professionals' (NADCP) 2017 national conference in Washington, DC.

In our session, there were peers, recovery coaches, judges, attorneys, probation officers and a host of other treatment court professionals. The presentation was honest, raw and thought provoking. The testimonials on video were impactful. The importance of Pro-social integration into the community with sober events was so well received and the interests expressed was exciting.
